

Terms and Conditions for Dash to Amici Events & Catering Promotion

- 1. These Terms and Conditions for the Dash to Amici Events & Catering ("**Promotion**") are binding on all persons participating in the Promotion jointly organised by Telecom Equipment Pte Ltd ("**Singtel**") and Amici Events & Catering Pte Ltd ("**Merchant**" or "**Amici"**).
