

## Terms and Conditions for Dash to ChildAid 2020 Charity Fundraising

The Dash to Donations to Charities Fundraising (the “**Fundraising**”) is a fundraising jointly organised by Telecom Equipment Pte Ltd (“**Singtel**”), The Straits Times School Pocket Money Fund (STSPMF) and The Business Times Budding Artists Fund (BTBAF) (“**Charities**”) subject to these Terms and Conditions (“**Terms and Conditions**”). By participating in this Fundraising, all Donors shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of Singtel, which shall be final and binding in all respects.

1. The Fundraising is available from 11 Jul 2020 and will end on 30 November 2020 (both dates inclusive) (the “**Fundraising Period**”).

### Eligibility

2. To be eligible for the Fundraising:
  - a. The Donors’ Dash Account must be and remain valid, and must not for any reason be terminated and/or suspended, during the Fundraising Period; and
  - b. The Donors must comply at all times with the terms and conditions governing the use of Dash, including, but not limited to, the Dash Terms and Conditions (which may be accessed at <http://www.dash.com.sg/terms>).
3. Singtel reserves the right to request for the Donor’s proof of identity (as may be acceptable to Singtel and in accordance with Singtel’s records) for the purposes of verifying that the Dash Account from which the Eligible Transactions have been made is registered to the Donor. In the absence of such verification as requested, Singtel shall be entitled in its discretion to disqualify the Donor from the Fundraising, and the Donor shall have no claim whatsoever against Singtel in such event.

### Conditions of Fundraising

5. Existing dash customers (“**Donors**”) who have successfully donated at least a minimum of S\$1 via Dash ‘Charity in-app function on their Android devices, or any amounts via Dash SGQR and/or ‘Charity’ in-app on any devices to the following Charities (“**Eligible Transactions**”) shall be entitled to receive a tax-deductible receipt (“**Receipt**”) from the respective Charities provided that they consent to the following:
  - (i) Singtel’s collection, usage, disclosure of the Donors’ personal data and/or information to the respective Charities such as The Straits Times School Pocket Money Fund (STSPMF) and The Business Times Budding Artists Fund (BTBAF) in accordance with Clause 7 of these Terms and Conditions; and
  - (ii) Provide the accurate and complete set of personal information at all times.
6. Subject to Clause 5(ii) of these Terms and Conditions, any Donors who have successfully made donations via the various channels stipulated above in Clause 5, shall also be required to update their personal information from time to time with Singtel and/or the relevant Charities.
7. In the event the Donors fail to comply with Clause 6, the Donors acknowledge that they shall not be entitled to receive the Receipt from the respective Charities without any liabilities to Singtel.

## **General**

8. This Fundraising may not be combined with any other on-going fundraisings and/or promotions offered by Singtel unless otherwise stated.
9. By participating in the Fundraising, the Donors consent to Singtel's collection, holding, storage, use, processing, transfer, disclosure and/or reporting (whether directly or indirectly) to any the relevant Charities such as The Straits Times School Pocket Money Fund (STSPMF) and The Business Times Budding Artists Fund (BTBAF) , of the Donors' personal data and/or information provided to Singtel, for tax deductibility purposes in relation to the Donors' donations and for the purpose of obtaining the relevant Receipt for the Donors' donations ; and the Donors further consent and acknowledge that the Donors' personal data and/or information (i) will also be processed in line with Singtel's privacy statement available at <https://dash.com.sg/wp-content/uploads/2016/04/privacy-policy.pdf>; (ii) the and (ii) may be used in accordance with Singtel's policies, terms and conditions or notices made available by Singtel from time to time.
10. Singtel reserves the right to, at its sole and absolute discretion, vary, modify and amend any of these Terms and Conditions and/or to suspend, discontinue or terminate the Fundraising at any time without prior notification, or liability to any party.
11. Singtel reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Fundraising, including the Donors' eligibility and the applicable criteria. Singtel's determination of all matters relating to this Fundraising shall be final and binding and no appeal or objection on any grounds will be entertained.
12. In the event of any inconsistency between these Terms and Conditions and any brochure, marketing or Fundraising material relating to the Fundraising, these Terms and Conditions shall prevail.
13. By participating in the Fundraising, each Donor agrees to fully and effectively indemnify, defend and hold harmless Singtel and/or the relevant Charities from and against any and all rights, demands, claims, causes of action, losses, damages, costs and expenses whatsoever that the Donor may have, or which may arise, whether in whole or in part, and whether directly or indirectly, due to or arising out of participation in the Fundraising. These obligations will continue to survive the expiry or termination of the Fundraising.
14. To the extent permitted by law, Singtel shall not be liable in any way to any Donors or any other person for any losses or damages of any kind, including but not limited to direct, indirect, incidental, consequential, special or punitive damages arising out of or in connection with the Fundraising, including without limitation, from any late or non-notification, any error in computing chances, any technical, hardware or software breakdown, malfunction or defects, failed delayed or incorrect transactions, lost or unavailable network connections or any notice that is lost or misdirected.
15. Singtel is not an agent of the Charities. The receipt and/or any information obtained from the Charities shall be subject to such other terms and conditions as may be imposed by the Charities, and you agree to be bound by such terms.
16. These Terms shall be subject to and construed in accordance with the laws of Singapore and the

Donors hereby submit to the exclusive jurisdiction of the courts of the Republic of Singapore.

17. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
