

## Terms and Conditions for Dash to FairPrice's Online Promotion

- 1. These Terms and Conditions for the Dash to FairPrice's Online Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised by Telecom Equipment Pte Ltd ("**Singtel**") and NTUC FairPrice Co-operative Ltd ("**Merchant**" or "**FairPrice**")
- 2. The Promotion shall be for a period starting from 9<sup>th</sup> September 2020 to 31<sup>st</sup> December 2020 (inclusive of both dates) ("**Promotion Period**").
