

Terms and Conditions for Dash to Fareast Flora Promotion

- 1. These Terms and Conditions for the Dash to Fareast Flora Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised by Telecom Equipment Pte Ltd ("**Singtel**") and Fareast Flora Pte Ltd ("**Merchant**" or "**Fareast Flora**").
- 2. The Promotion shall be for the period starting from 15th November 2020 and ending on 31st December 2020 (inclusive of both dates) ("**Promotion Period**").

- 4. Subject to Clause 3 of these Terms and Conditions, Customers must sign up or be logged into a Fareast Flora account.
- 5. To be eligible for the Promotion:
 - (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period; and
