

Terms and Conditions for Dash to IMDA Nets Hawker Go Digital Promotion

- 1. The Dash to IMDA Nets Hawker Go Digital Promotion (the "**Promotion**") is a closed door lucky draw organized by Info-communications Media Development ("**Merchant**" or "**IMDA**") (which includes the Singapore Digital Office ("**SDO**")) under the Hawkers Go Digital initiative ("**HGD Initiative**") whereby SingCash Pte Ltd ("**Singtel**") is one of the payment schemes participant and is open to all individuals.
- 2. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of Singtel and/or IMDA, which shall be final and binding in all respects.
- 3. The Promotion is available from 1st November 2020 and will end on 30 April 2021 (both dates inclusive) (the "**Promotion Period No.1**").

Eligibility

- 4. To be eligible for the Promotion, the participant must:
 - a) hold a valid Singtel Dash Balance Account, which must be and remain valid and must not for any reason be terminated and/or suspended, during the Promotion Period;
 - b) comply at all times (including, but not limited to, in making the Eligible Transaction) with the terms and conditions governing the use of Dash Balance, including, but not limited to, the Dash Terms and Conditions (which may be accessed at https://www.dash.com.sg/terms-and-conditions/).
 - c) Employees of the Singtel Group of Companies and its appointed advertising, media and auditing agencies and any other parties who are directly involved in the organizing, promoting or conducting of the Lucky Draws shall not be eligible to participate in the Promotion. Notwithstanding this Clause 4(c), employees of IMDA and/or SDO may be subjected to the internal policies of IMDA and SDO relating to the eligibility of their employees to win prizes under the Lucky Draw. Such internal policies, relating to the employees of IMDA, may also be set by participating schemes/wallets and/or other service providers related to the Lucky Draw.
 - d) For the avoidance of doubt, participation in the Promotion is open to individuals only. Corporate or other entities shall not be eligible to participate in the Promotion.

Conduct of the Lucky Draw

5. A lucky draw (the "**Lucky Draw**") will be conducted in respect of the Relevant Period by IMDA/SDO on the Lucky Draw Date as stated in the table below or on such other date, time and venue as may be determined at the sole and absolute discretion of IMDA and/or SDO.

- 6. Each participant shall be entitled to Lucky Draw chance(s) according to the amounts spent for any successful Payment Transaction(s) made by the participant using the Dash app to scan and pay at participating hawkers outlets who have adopted the Unified E-payment Solution ("UEPS") under the HGD initiative, which include without limitation, registered stallholders at NEA hawker centres, registered stallholders at the HDB coffeeshops and registered stallholders at the JTC industrial canteens, during the Promotion Period, in accordance with these Terms and Conditions and applicable Dash Terms and Conditions (which may be accessed at http://www.dash.com.sg/terms). This Promotion shall be limited to one prize per month per Winner of each respective Lucky Draw based on the particular payment scheme/wallet which they have used.
- 7. For the purpose of this Promotion, participants who successfully use Dash app to pay at participating hawkers shall be entitled to incremental Lucky Draw Chances based on the amount spent rounded to the lower dollars. For example, a successful Payment Transaction of S\$3.50 will entitle the participant with 3 Lucky Draw Chances, while a successful Payment Transaction will entitle the participant with 11 Lucky Draw Chances.
- 8. For each of respective Lucky Draw following prizes will be given out to the winners who successfully win the Lucky Draw ("Winners") per month:

- 9. Winners will be selected at random from NETS transaction database(s) by computerized means in the presence of an IMDA.SDO appointed auditor in the presence of an authorised personnel of IMDA on the Lucky Draw Date. Subject to Clause 6 of these Terms and Conditions, Winners are able to win prizes over multiple monthly draws during the entire Promotion Period.
- 10. All Winners will be notified by Singtel or the respective payment schemes/wallets via SMS or their Singtel Dash registered telephone number within fourteen (14) working weeks after the Lucky Draw Date. In addition, Winners shall be fourteen (14) working days from the date of being contact to provide their full contact information and consent that such information (appropriately masked) may be published by IMDA/SDO on the Lucky Draw website (go.gov.sg/scanpaywin). Winners who do not provide their full contact information or do not consent to the publication of their information, including personal information, shall be deemed to have rejected their Prizes, which shall be donated to charity.
- 11. In addition, all Winners for this Promotion will be announced on Dash's, IMDA's and/or NET's website.
- 12. By successfully use Dash app to pay at participating hawkers, the participants consent to Singtel Dash collecting, using and disclosing personal information to its affiliates and/or for any purposes relating to this Promotion and/or Lucky(s), including without limitation:



- 1. Using the participants' personal information to contact and notify on any winnings (if applicable), and to get the necessary details (kyc, bank account no.) for disbursement of Prizes, if applicable.
- 2. Sharing the participants' personal information with IMDA/SDO and NETS, and/or to verify that the Payment Transactions are legitimate and to publicize on the behalf of the relevant participants.
- 13. The monthly Prizes shall be credited within twenty (20) working days after the period where the Winners have been notified and have consented to the publication of their information, including personal information as set out above in these Terms and Conditions.
- 14. Any Prize which is not claimed in accordance with the provisions of these Terms and Conditions within the Collection Period will be forfeited at the sole and absolute discretion of IMDA/SDO, and the Winner shall not be entitled to any compensation for the same. IMDA/SDO reserves the right to draw reserve Winners to replace any previously selected Winner(s) who are or may be subsequently found to be ineligible or disqualified. In addition, any Prize which is not claimed within two (2) months from the date of the Lucky Draw shall be donated to the charity named, ComChest, in the sole and absolute discretion of IMDA/SDO.
- 15. All Prizes won or accepted shall be given on an "as-is" basis and are non-transferable, non-assignable, non-exchangeable and non-redeemable for cash and/or any other items. No payment or compensation whether in cash, credit or kind shall be made for any uncollected, lost, misplaced, defaced, stolen or damaged Prizes.

Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Prizes and assumes no liability or responsibility for the acts or omissions of the merchants and/or suppliers of the Prizes or any non-performance or defects in the Prizes. Any dispute about the value, condition or performance of the Prizes is to be resolved directly with the relevant merchants and/or suppliers of the Prizes.
- 17. Singtel reserves the right to disqualify any one or more of the Winners following Singtel's announcement at the Lucky Draw, if
 - a) the Winners are determined, in Singtel's sole discretion, to be ineligible for any reason whatsoever,
 - b) at any time, Singtel, at its sole and absolute discretion, suspects any fraud in relation to, and/or misuse of, the Winner's Dash Balance Account; or
 - c) the phone number which is registered in respect of the Winner's Dash Balance Account is for any reason changed (whether by the Winner or any other person, with or without the consent or knowledge of the Winner) during the Relevant Period or at any time before the collection of the Prize by the Winner in accordance with these Terms and Conditions.
- 18. By accepting the Prize, the Winner agrees that Singtel may use the Winner's name, addresses, personal details, photographs without further consideration.



General

- 19. Singtel and/or IMDA/SDO reserves the right to, at its sole and absolute discretion, vary, modify and amend any of these Terms and Conditions and/or to suspend, discontinue or terminate the Promotion/Lucky Draw at any time without prior notification, or liability to any party. - 21. In the event of any inconsistency between these Terms and Conditions and any brochure, marketing or promotion material relating to the Promotion, these Terms and Conditions shall prevail.
- 22. By participating in the Promotion and/or the Lucky Draw, each participant agrees to fully and effectively indemnify, defend and hold harmless Singtel and/or IMDA/SDO from and against any and all rights, demands, claims, causes of action, losses, damages, costs and expenses whatsoever that the participant may have, or which may arise, whether in whole or in part, and whether directly or indirectly, due to or arising out of participation in the Promotion and/or the Lucky Draw. - 24. These Terms shall be subject to and construed in accordance with the laws of Singapore and the participants hereby submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
- 25. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
