

## Terms and Conditions for Dash at Lazada CNY Promotion

- 1. These Terms and Conditions for the Dash at Lazada CNY Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised by SingCash Pte Ltd ("**Singtel**") and Lazada Singapore Pte. Ltd. ("**Merchant** or "Lazada").
- 2. The Promotion shall be from 17 to 24 January 2021 (inclusive of both dates) ("Promotion Period").

Under the Promotion, and subject to these Terms and Conditions, existing Dash Customers ("Eligible Customers") may access Dash landing page on Lazada (<u>link</u>) and Lazada's Application during the Promotion Period to collect Dash vouchers ("Voucher"). There are 2 vouchers an Eligible Customer is entitled to:

- 3.1. A discount of six dollars (S\$6) ("**Discount**") provided that a minimum of S\$88 worth of goods and/or services are successfully purchased using Dash Visa Virtual Account ("**Dash Payment Transactions**") during the Promotion Period. This Discount is valid to a maximum redemption of 416 during this Promotion Period. Each Eligible Customer shall only be entitled to a maximum of one (1) redemption during the Promotion Period.
- 3.2. A discount of ten dollars (S\$10) ("**Discount**") provided that a minimum of S\$128 worth of goods and/or services are successfully purchased using Dash Visa Virtual Account ("**Dash Payment Transactions**") during the Promotion Period. This Discount is valid to a maximum redemption of 250 during this Promotion Period. Each Eligible Customer shall only be entitled to a maximum of one (1) redemption during the Promotion Period.

These Vouchers can be collected from 17 Jan'21 12am - 24 Jan'21 1159pm, vouchers are refreshed daily at 9am, 12pm and 6pm. Voucher redemption is valid only from 17 Jan'21 12am to 24 Jan'21 1159pm. By redeeming the Lazada's Voucher(s) referred to in this Clause, the Eligible Customers consent to the terms & conditions by Merchant available <a href="here">here</a>. Vouchers cannot be stacked or used concurrently in a single purchase cart check-out.

- 3. To be eligible for the Promotion:
  - (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period; and
  - (b) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions, Terms and Conditions for Dash Visa Virtual Account (which may be accessed at <a href="http://www.dash.com.sg/terms">http://www.dash.com.sg/terms</a>).
- 4. Voucher is applicable sitewide on Lazada, excluding RedMart orders.
- 5. Not applicable for purchase of any gold items, digital Goods and Toddler Formula (0 12 months)
- 6. Voucher is applicable for redemption on Lazada's mobile application only.
- 7. Save and except for the cashback payable from the First Use Dash Cashback Promotion, this Promotion may not be combined with any other on-going promotions by Singtel unless otherwise stated.
- 8. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you.

- 14. If there is any inconsistency between these Terms and Conditions and such other applicable terms and conditions, these Terms and Conditions shall prevail to the extent of such inconsistency.
- 15. These Terms shall be subject to and construed in accordance with the laws of Singapore and you hereby submit to the non-exclusive jurisdiction of the courts of Singapore.
- 16. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act, Chapter 53B of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
