

Terms and Conditions for Dash on One Faber Group Promotion

- 1. These Terms and Conditions for the Dash on One Faber Group Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised by SingCash Pte Ltd ("**Singtel**") and Mount Faber Leisure Group Pte Ltd ("**Merchant**" or "**Mount Faber Leisure Group**").
- 2. The Promotion shall be held from 19 February to 30 April 2021 (inclusive of both dates) ("**Promotion Period**").
- 3. Under the Promotion, and subject to these Terms and Conditions, eligible Dash customers ("Eligible Customers") who have successfully made full payment transactions using Dash ("Dash Payment Transactions") during the Promotion Period shall be entitled to 25% off Cable Car Sky Pass (Round Trip) with a Free upgrade to unlimited rides ("Discount").
- 4. Promotional tickets can be purchased at Singapore Cable Car Ticketing counters or online at http://lfabergroup.com/dash and is valid for purchase of up to 6 Cable Car tickets each per transaction
- 5. Promotion is only applicable to prevailing standard rate tickets.
- 6. All completed and confirmed transaction cannot be cancelled, refunded or amended
- 7. Promotion is not valid with other promotions, discounts and privileges.
- 8. Promotional tickets purchased or redeemed are only valid for same day use.
- 9. Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended;
 - (a) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions and Terms and Conditions for Dash Visa Virtual Account (which may be accessed at http://www.dash.com.sg/terms); and
 - (b) You must hold an existing Dash Account, or open a new Dash Account prior to participating in this Promotion.
- 10. Notwithstanding any provision in these Terms and Conditions:
 - (a) Singtel and/or Mount Faber Leisure Group reserves the right to change the terms and conditions at any time without prior notice
 - the Promotion is terminated in accordance with these Terms and Conditions at any time during the Relevant Date; and/or
 - (ii) the phone number which is registered in respect of your Dash Balance is for any reason changed (whether by you or any other person, with or without your knowledge) during the Relevant Date.

Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in their sole and absolute discretion and without prior notice to you. In the event of such termination, Singtel may at its absolute discretion elect not to award the Discount in respect of the terminated Promotion.



- 12. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of an Eligible Customer to enter and participate in this Promotion and your entitlement to the Discount.
