

## Terms and Conditions for Dash to Scoopy's Gelataria Promotion

- 1. These Terms and Conditions for the Dash to Scoopy's Gelataria ("**Promotion**") are binding on all persons participating in the Promotion jointly organised by Telecom Equipment Pte Ltd ("**Singtel**") and Scoopy's Gelateria Pte Ltd ("**Merchant**" or "**Scoopy**")
- 2. The Promotion shall be a period starting from 17<sup>th</sup> July 2020 to 31<sup>st</sup> July 2020 (inclusive of both dates) ("**Promotion Period**").
- 3. Under the Promotion, and subject to these Terms and Conditions, Singtel Dash customers ("Eligible Customers") who purchase S\$60 or more online on Scoopy's website on <u>https://order.icecreamandicecream.com/</u> during the Promotion Period, will enjoy a discount of S\$5 ("Discount") off their purchases and a S\$10 Toast Box ("Toast Box") cash voucher with validity date till 30<sup>th</sup> November ("Voucher") provided that they have successfully made full payment using Singtel Dash Visa Virtual Account.

Subject to these Terms and Conditions, the Promotion is only valid to Eligible Customers who key in the promo code consisting of the first 6 digits of their Dash Visa Virtual account ("**Promo Code**") in the discount code box before checking out for payment online on Scoopy's website via Singtel Dash Visa Virtual account.
- 5. Notwithstanding anything to the contrary in these Terms and Conditions, the Discount of S\$5 referred to in Clause 3 of these Terms and Conditions will exclude delivery charges.
- 6. This Promotion is limited to one (1) redemption per Eligible Customer.
- 7. Provided that the Merchant's, Toast Box's and these Terms and Conditions are satisfied, the Eligible Customers will receive the Voucher on the same day of delivery of their main purchases.
- 8. The Promo Code is not applicable for guest checkouts or in-store purchases and cannot, in any event, be used with any other promotions or Scoopy s e-voucher redemptions.
- 4. To be eligible for the Promotion:
  - (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period; and
  - (b) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions, Terms and Conditions for Dash Visa Virtual Account (which may be accessed at <u>http://www.dash.com.sg/terms</u>).
- 5. Save and except for the cashback payable from the First Use Dash Cashback Promotion, this Promotion may not be combined with any other on-going promotions by Singtel unless otherwise stated.
- 6. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you.
- 7. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of a customer to enter and participate in this Promotion.

- 12. If there is any inconsistency between these Terms and Conditions and such other applicable terms and conditions, these Terms and Conditions shall prevail to the extent of such inconsistency.
- 13. These Terms shall be subject to and construed in accordance with the laws of Singapore and you hereby submit to the non-exclusive jurisdiction of the courts of Singapore.
- 14. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act, Chapter 53B of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
