

## Terms and Conditions for Dash Shopee Promotion

- 1. These Terms and Conditions ("**Terms and Conditions**") for the Dash Shopee Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised, conducted and operated by SingCash Pte Ltd ("**Singtel**") and Shopee ("**Merchant**").
- 2. The Promotion commences on 4 January 2021 and will end on 29 March 2021 (both dates inclusive) ("**Promotion Period**"). For the purpose of these Terms and Conditions, the term "**Promotion**" shall refer to either Promotion No.1 or Promotion No.2.
- 3. Under the Promotion No.1, and subject to these Terms and Conditions, eligible Dash Customers ("Eligible Customers") shall be entitled to receive the following discount off goods purchased from the Merchant at https://shopee.sg/ or Shopee App ('Discount') via Dash during the Promotion Period:

- 5. This Promotion may not be combined with any other on-going promotions offered by Singtel. Unless otherwise stated, this Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions by the Merchant.
- 6. To be eligible for the Discount:



- (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period.
- (b) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions (which may be accessed at <a href="http://www.dash.com.sg/terms">http://www.dash.com.sg/terms</a>).
- 7. The Discount is not exchangeable for cash
- 8. In addition, under this Promotion No.2, and subject to these Terms and Conditions and the First Use Cashback Terms and Conditions, any new dash users ("New Customers") who sign up and purchase a minimum of S\$0.10 worth of goods and services online on Shopee's website during the Promotion Period shall be entitled to receive a maximum of S\$2 cashback provided that the New Customers successfully make the payment using Singtel Dash Virtual account. This Promotion No.2 shall be limited to a maximum of one hundred and thirty four (134) redemptions during the Promotion Period. Notwithstanding any provision in these Terms and Conditions, Singtel shall be entitled, at Singtel's sole and absolute discretion and without notice to you, to claw-back from your Dash Balance, the Discount which has been granted to you in connection with these Terms and Conditions (or any part thereof), if such Discount has, in Singtel's or Merchant's sole opinion, been wrongfully granted to you for any reason whatsoever.
- 10. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you. In the event of such termination, Singtel may at its absolute discretion elect not to grant you the Discount in respect of the terminated Promotion.
- 11. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of an Eligible Customer to enter and participate in this Promotion and your entitlement to the Discount.
- 12. Single's decisions on all matters relating to or in connection with this Promotion and these Terms and Conditions shall be final. No correspondence or claims will be entertained.
- 13. Singtel is not an agent of the Merchant. Goods purchased from or through the Merchant ("Relevant Goods") shall be subject to such other terms and conditions as may be imposed by Merchant and/or the respective suppliers or merchants for such goods ("Suppliers"), and you agree to be bound by such terms.
- 14. Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Relevant Goods and assumes no liability or responsibility for the acts or omissions of the Merchant/Suppliers. Any dispute about the value, condition or performance of any of the Relevant Goods is to be resolved directly with the relevant Merchant/Suppliers.
- 15. Singtel shall not in any event be liable in any way to you or any person for any loss, liability, damages or expense whatosever, howsoever arising, in connection with this Promotion.
- 16. These Terms and Conditions are to be read in conjunction with other applicable terms and conditions which can be accessed at <a href="http://www.dash.com.sg/terms">http://www.dash.com.sg/terms</a>). If there is any inconsistency between these Terms and Conditions and such other applicable terms and conditions, these Terms and Conditions shall prevail to the extent of such inconsistency.



- 17. These Terms shall be subject to and construed in accordance with the laws of Singapore and you hereby submit to the non-exclusive jurisdiction of the courts of Singapore.
- 18. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act, Chapter 53B of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
