

Terms and Conditions for Dash to Taobao Promotion

- 1. These Terms and Conditions for the Dash to Taobao Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised by Telecom Equipment Pte Ltd ("**Singtel**") and Taobao Zhejiang Tmall Technology Co. Ltd. ("**Merchant**" or "**Taobao**")
- The Promotion shall be the periods starting from 9th September 2020 to 11th September 2020 to 31st October 2020 2359 ("Promotion Period No.1") and/or from 9th September 2020 to 31st October 2020 2359 ("Promotion Period No.2") (inclusive of both dates) ("Promotion Period").
- 3. Under the Promotion No.1, and subject to these Terms and Conditions, Singtel Dash customers ("**Eligible Customers**") who purchase any items on Taobao's mobile application during the Promotion Period No.1, will enjoy a discount of \$50RMB ("**Discount**") off their purchases provided that they have successfully made full payment using Singtel Dash Visa Virtual Account, subject to a minimum spending of \$499RMB.
- 4. Subject to the eligibility conditions set out in Clause 3 of these Terms and Conditions, the Promotion No.1 is only valid to Eligible Customers who key in the promotion code "DBD50" ("Promo Code No.1") in the discount code box before checking out using a Singapore address for payment online on Taobao's mobile application via Singtel Dash Visa Virtual account.
- 5. Under the Promotion No. 2, existing Singtel Dash Customers who are first time customers of Taobao ("New Customers") and make their first purchase of any items on Taobao's mobile application during Promotion Period No.2, will enjoy a discount of \$40RMB ("New Discount") off their purchases provided that they have successfully made full payment using Singtel Dash Visa Virtual Account, subject to a minimum spending \$100RMB.
- 6. Subject to the eligibility conditions set out in Clause 5 of these Terms and Conditions, the Promotion No. 2 is only valid to Eligible Customers who key in the promotion code "DASHNEW40" ("Promo Code No.2") in the discount code box before checking out using a Singapore address for payment online on Taobao's mobile application via Singtel Dash Visa Virtual account. For the purpose of these Terms and Conditions, the reference to the term "Promo Code(s") shall refer to Promo Code No.1 and/or Promo Code No.2.
- 7. The Promotion No.1 and Promotion No.2 shall be valid on purchases made online at Taobao's mobile application. Promotion No. 1 and Promotion No. 2 are not stackable.
- 8. For the avoidance of doubt, the following is a table of summary setting out the promotion mechanics for Promotion No.1 and Promotion No.2:

- 9. Both Promotions are subjected to limited number of redemptions, while Promo Codes are limited and based on first come, first serve basis. In addition, this Promotion is limited to a maximum of one (1) redemption per Eligible Customer during the Promotion Period.
- 10. This Promotion is only applicable on Taobao's mobile application and Promo Codes shall only be valid for purchase of any tangible goods and/or items online on Taobao's mobile application.
- 11. Singapore address must be used at checkout.
- 12. Notwithstanding anything to the contrary in these Terms and Conditions, the Additional Discount and/or Discount are stackable with shop vouchers, credit card offers and hongbaos offer, which may vary from time to time by Singtel.
- 13. To be eligible for the Promotion:
 - (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period; and
 - (b) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions, Terms and Conditions for Dash Visa Virtual Account (which may be accessed at <u>http://www.dash.com.sg/terms</u>).
- 14. Save and except for the cashback payable from the First Use Dash Cashback Promotion, this Promotion may not be combined with any other on-going promotions by Singtel unless otherwise stated.
- 15. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you.
- 16. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of a customer to enter and participate in this Promotion.
- 17. Singtel's decisions on all matters relating to or in connection with this Promotion and these Terms and Conditions shall be final. No correspondence or claims will be entertained.
- 18. Singtel shall not in any event be liable in any way to you or any person for any loss, liability, damages or expense whatsoever, howsoever arising, in connection with this Promotion.
- 19. Singtel is not an agent for the Merchant. The goods and/or services purchased or obtained from the Merchant shall be subject to such other terms and conditions as may be imposed by the Merchant, and you agree to be bound by such terms.
- 20. Singtel makes no warranty or representation as to the quality, value, merchantability or



fitness for purpose of the goods and/or services supplied by the Merchant and assumes no liability or responsibility for the acts or omissions of the Merchant. Any dispute about the value, condition or performance of any of such goods and/or services is to be resolved directly with the Merchant.

- 21. If there is any inconsistency between these Terms and Conditions and such other applicable terms and conditions, these Terms and Conditions shall prevail to the extent of such inconsistency.
- 22. These Terms shall be subject to and construed in accordance with the laws of Singapore and you hereby submit to the non-exclusive jurisdiction of the courts of Singapore.
 - 23. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act, Chapter 53B of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
