

Terms and Conditions for Dash to Traveloka Promotion

- 1. These Terms and Conditions for the Dash to Traveloka (**Promotion**") are binding on all persons participating in the Promotion jointly organised by Telecom Equipment Pte Ltd ("**Singtel**") and Traveloka ("**Merchant**" or "**Traveloka**").
- 2. The Promotion shall be a period starting from 15th October 2020 to 30th November 2020 (inclusive of both dates) ("**Promotion Period**").
- 3. Under the Promotion, and subject to these Terms and Conditions, Singtel Dash customers ("Eligible Customers") who successfully made a hotel booking for a minimum of S\$100 during the Promotion Period on Traveloka's App, will enjoy the following discounts ("Discounts"), provided that the Eligible Customers have successfully made full payment and checked out using the applicable promo codes and with Singtel Dash Visa Virtual account

- 4. This Promotion shall be valid for all hotels and room types available on Traveloka, except "Pay upon Check-In" rooms and selected hotel chains due to hotel policy.
- 5. In order to enjoy this Promotion, the Eligible Customers shall be required to meet the eligibility conditions set out in Clauses 3 and 4 by transacting on the Traveloka application.
- 6. Any Eligible Customers who satisfy the conditions set out in Clauses 3 and 4 of these Terms and Conditions, shall also be entitled to enjoy flexible free cancellation up till 24 hours before their assigned stay.
- 7. The Promotion is not applicable for guest checkouts or in-store purchases, however, Eligible Customers shall be entitled to the Discount in addition to any other offers by Traveloka.
- 8. To be eligible for the Promotion:
 - (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period; and
 - (b) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions, Terms and Conditions for Dash Visa Virtual Account(which may be accessed at http://www.dash.com.sg/terms).
- 9. Save and except for the First Use Cashback Promotion, this Promotion may not be combined with any other on-going promotions by Singtel unless otherwise stated.
- 10. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you. In the event of such termination, Singtel may at its absolute discretion



elect not to award the Discount in respect of the terminated Promotion.

- 11. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of a customer to enter and participate in this Promotion and your entitlement to the Discount.
- 12. Singtel's decisions on all matters relating to or in connection with this Promotion and these Terms and Conditions shall be final. No correspondence or claims will be entertained.
- 13. Singtel shall not in any event be liable in any way to you or any person for any loss, liability, damages or expense whatsoever, howsoever arising, in connection with this Promotion (including, but not limited to, that arising from or in connection with any failure or delay by Singtel to credit the Discount (or any part thereof) to you or any person).
- 14. Singtel is not an agent for the Merchant. The goods and/or services purchased or obtained from the Merchant shall be subject to such other terms and conditions as may be imposed by the Merchant, and you agree to be bound by such terms.

Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the goods and/or services supplied by the Merchant and assumes no liability or responsibility for the acts or omissions of the Merchant. Any dispute about the value, condition or performance of any of such goods and/or services is to be resolved directly with the Merchant.
- 16. If there is any inconsistency between these Terms and Conditions and such other applicable terms and conditions, these Terms and Conditions shall prevail to the extent of such inconsistency.
- 17. These Terms shall be subject to and construed in accordance with the laws of Singapore and you hereby submit to the non-exclusive jurisdiction of the courts of Singapore.
- 18. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act, Chapter 53B of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
