

Terms and Conditions for Dash to Unboxed Apple Iphone 12 Promotion

- 1. These Terms and Conditions for the Dash to Unboxed Apple Iphone 12 Promotion ("**Promotion**") are binding on all persons participating in the Promotion is organised by Telecom Equipment Pte Ltd ("**Singtel**").
- 2. The Promotion shall be a period starting from 23rd October 2020 to 31st December 2020 (inclusive of both dates) ("**Promotion Period**").
- 3. Under the Promotion, and subject to these Terms and Conditions, Singtel Dash customers ("Eligible Customers") who purchase a minimum of S\$200 worth of Apple's accessories at Unboxed outlet located at Comcentre during the Promotion Period ("Eligible Transaction"), will enjoy S\$10 cashback ("Cashback"), provided that the Eligible Customers have successfully made full payment using Singtel Dash via QR code.
- 4. This Promotion is limited to maximum cap of one thousand (1,000) redemptions during the Promotion Period, wherein each Eligible Customer is entitled to one (1) redemption during the Promotion Period.
- 5. In addition, new Dash customers ("New Customers") shall be entitled to S\$2 credits ("New Cashback") and 800 reward points provided that they sign up using the promo code as advertised by Unboxed ("Promo Code") wherein the first S\$2 will be credited into each respective New Customer's Dash account upon sign up with the Promo Code and additional 800 reward points will be credited on each respective New Customer's first successful Dash transaction.
- 6. To be eligible for the Promotion:
 - (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period; and
 - (b) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions (which may be accessed at http://www.dash.com.sg/terms).
- 7. The Cashback and/or Additional Cashback Additional Cashback are computed based on 2 decimal places per Dash Payment Transaction without any rounding and will be credited to your Dash Balance on the next Calendar Day following the Eligible Transaction. For the purposes of these Terms and Conditions, "Calendar Day" means any day within a calendar month in Singapore.
- 8. The Cashback and/or Additional Cashback Additional Cashback shall be inclusive of all cashbacks, if any, payable in respect of the qualifying Dash payment transactions under any other promotions organised by Singtel, unless otherwise stated.
- The Cashback and/or Additional Cashback Additional Cashback is not exchangeable for cash, goods and/or services
- 10. Save and except for the First Use Cashback Promotion expressly mentioned in Clause 5 of these Terms and Conditions, this Promotion may not be combined with any other on-going promotions by Singtel unless otherwise stated. This Promotion is also not applicable for any corporate event bookings.



- 11. Notwithstanding any provision in these Terms and Conditions:
 - (a) Singtel shall not be required to credit the Cashback and/or Additional Cashbackor any part thereof to your Dash Balance in connection with these Terms and Conditions, if:
 - at any time Singtel, at its sole and absolute discretion, suspects any fraud in relation to, and/or misuse of your Dash Balance (whether by you or any other person, with or without your knowledge);
 - ii. your Dash Balance and/or your access to or use of Dash is for any reason terminated and/or suspended during the period from the commencement of the Promotion Period to the date on which Singtel credits your Dash Balance with the Cashback and/or Additional Cashback Additional Cashbackpursuant to these Terms and Conditions (both dates inclusive) ("Relevant Period");
 - iii. your Dash Balance following the credit of the Cashback and/or Additional Cashback Additional Cashbackwill exceed the wallet limit of \$999 under the Dash Terms and Conditions:
 - iv. the Promotion is terminated in accordance with these Terms and Conditions at any time during the Relevant Period; and/o
 - v. the phone number which is registered in respect of your Dash Balance is for any reason changed (whether by you or any other person, with or without your knowledge) during the Relevant Period.
 - (b) Singtel shall be entitled, at Singtel's sole and absolute discretion and without notice to you, to claw-back from your Dash Balance, the Cashback and/or Additional Cashback which has been credited to your Dash Balance in connection with these Terms and Conditions (or any part thereof), if such amount has, in Singtel's sole opinion, been wrongfully credited to you for any reason whatsoever
- 12. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you. In the event of such termination, Singtel may at its absolute discretion elect not to award the Cashback and/or Additional Cashback in respect of the terminated Promotion.
- 13. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of a customer to enter and participate in this Promotion and your entitlement to the Cashback and/or Additional Cashback.
- 14. Singtel's decisions on all matters relating to or in connection with this Promotion and these Terms and Conditions shall be final. No correspondence or claims will be entertained.
- 15. Singtel shall not in any event be liable in any way to you or any person for any loss, liability, damages or expense whatsoever, howsoever arising, in connection with this Promotion (including, but not limited to, that arising from or in connection with any failure or delay by Singtel to credit the Cashback and/or Additional Cashback (or any part thereof) to you or any person).
- 16. Singtel is not an agent for the Merchant. The goods and/or services purchased or obtained from the Merchant shall be subject to such other terms and conditions as may be imposed by the Merchant, and you agree to be bound by such terms.



- 17. Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the goods and/or services supplied by the Merchant and assumes no liability or responsibility for the acts or omissions of the Merchant. Any dispute about the value, condition or performance of any of such goods and/or services is to be resolved directly with the Merchant.
- 18. If there is any inconsistency between these Terms and Conditions and such other applicable terms and conditions, these Terms and Conditions shall prevail to the extent of such inconsistency.
- 19. These Terms shall be subject to and construed in accordance with the laws of Singapore and you hereby submit to the non-exclusive jurisdiction of the courts of Singapore.
- 20. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act, Chapter 53B of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
