

Terms and Conditions for Dash at WhyQ Promotion

- These Terms and Conditions for the Dash at WhyQ Promotion ("Promotion") are binding on all persons participating in the Promotion jointly organised by Telecom Equipment Pte Ltd ("Singtel") and WhyQ ("Merchant or WhyQ").
