

## Terms and Conditions for "International Airtime and Data Bonus Top-up Promotion"

- 1. These Terms and Conditions for the International Airtime and Data Bonus Top-up Promotion ("**Promotion**") are binding on all persons participating in the Promotion organised, conducted and operated by Telecom Equipment Pte Ltd ("**Singtel**").
- 2. The Promotion shall begin on 8 November 2020 and ends on 7 December 2020 including both dates ("**Promotion Period**").
- 3. Under the Promotion, and subject to these Terms and Conditions, selected Dash Customers ("Eligible Customers") who have successfully made top-ups of eligible denominations for overseas prepaid airtime and/or data through their Singtel Dash app during the Promotion Period ("Eligible Transaction") shall be entitled to receive extra airtime or data amounts in addition to their top up amounts ("Bonus"), capped at one (1) redemption per Eligible Customer per service (airtime and/or data) during Promotion Period.
- 4. To be eligible for the Bonus set out in Clause 4(b), any Eligible Customer shall be required to satisfy the following conditions by:
  - (a) Purchasing the following overseas prepaid airtime of eligible denominations through the Singtel Dash app; and

  - (b) DT One and/or Singtel reserves the right and authority to disqualify fraudulent transactions or abuse of the promotion, or any airtime top ups which Singtel deems, in its sole and absolute discretion, made not in accordance with these Terms and Conditions and/or any Singtel's Policies.
- 6. Subject to satisfying the conditions set out Clauses 3 and 4 of these Terms and Conditions, the Bonus will be credited automatically into the Eligible Customers' accounts, and no additional steps will be required to be undertaken by the Eligible Customers unless otherwise informed or decided by Singtel.
- 7. This Promotion is only valid for selected group of customers who meet Singtel's eligibility criteria, which shall change from time to time.
- 8. The Bonus is not exchangeable for cash or any other goods and/or services.
- 9. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you. In the event of such termination, Singtel may at its absolute discretion elect not to award the Bonus in respect of the terminated Promotion.
- 10. Singtel's decisions on all matters relating to or in connection with this Promotion and these Terms and Conditions shall be final. No correspondence or claims will be entertained.
- 11. Singtel shall not in any event be liable in any way to you or any person for any loss, liability, damages or expense whatsoever, howsoever arising, in connection with this Promotion (including, but not limited to, that arising from or in connection with any failure or delay by Singtel to credit the Bonus (or any part thereof) to you or any person).
- 12. Singtel is not an agent of any of the merchants participating in this Promotion ("Merchants"). The goods and/or services purchased or obtained from the Merchants shall be subject to such other terms and conditions as may be imposed by the respective Merchants, and you agree to be bound by such terms.
