

Terms and Conditions for Dash at Lazada 5.5 Promotion

1. These Terms and Conditions for the Dash at Lazada 5.5 Promotion (“**Promotion**”) are binding on all persons participating in the Promotion jointly organised by SingCash Pte Ltd (“**Singtel**”) and Lazada Singapore Pte. Ltd. (“**Merchant** or “**Lazada**”).
2. The Promotion shall be from 1 May 2021 to 9 May 2021 (inclusive of both dates) (“**Promotion Period**”).
3. Under the Promotion, and subject to these Terms and Conditions, existing Dash Customers (“**Eligible Customers**”) may access Lazada’s Application during the Promotion Period to collect Dash voucher (“**Voucher**”). This Voucher will entitle the Eligible Customer to obtain a discount of five dollars (S\$5) (“**Discount**”) provided that a minimum of S\$80 worth of goods and/or services are successfully purchased using Dash Visa Virtual Account (“**Dash Payment Transactions**”) during the Promotion Period. The Voucher can be collected from 0000hrs on 1 May’21 to 2359hrs on 9 May’21. Voucher collection is refreshed daily at 0900hrs, 1200hrs and 1800hrs. Voucher redemption is valid only from 0900hrs to 2359hrs from 5 May’21 to 9 May’21. By redeeming the Lazada’s Voucher(s) referred to in this Clause, the Eligible Customers consent to the terms & conditions by Merchant available [here](#).

This Promotion is valid to a maximum redemption of 1000 during this Promotion Period. In addition, each Eligible Customer shall only be entitled to a maximum of one (1) redemption during the Promotion Period.

4. To be eligible for the Promotion:
 - (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period; and
 - (b) You must comply at all times with the terms and conditions governing your use of Dash, including, but not limited to, the Dash Terms and Conditions, Terms and Conditions for Dash Visa Virtual Account (which may be accessed at <http://www.dash.com.sg/terms>).
5. Voucher is applicable sitewide on Lazada, excluding RedMart orders.
6. Not applicable for Gold, Digital Goods, Toddler Formula (0 - 12 months) and shipping charges.
7. Voucher is applicable for redemption on Lazada’s mobile application only.
8. Save and except for the rewards points receivable from the Dash First Use Promotion, this Promotion may not be combined with any other on-going promotions by Singtel unless otherwise stated.
9. Singtel reserves the right to terminate the Promotion in its entirety and/or to vary, amend, delete or supplement any of these Terms and Conditions, at any time, in its sole absolute discretion and without prior notice to you.
10. Notwithstanding any other provision of these Terms and Conditions, Singtel has the sole and absolute discretion to determine the eligibility of a customer to enter and participate in this Promotion.

Any dispute about the value, condition or performance of any of such goods and/or services is to be resolved directly with the Merchant.
15. If there is any inconsistency between these Terms and Conditions and such other applicable terms and conditions, these Terms and Conditions shall prevail to the extent of such inconsistency.
16. These Terms shall be subject to and construed in accordance with the laws of Singapore and you hereby submit to the non-exclusive jurisdiction of the courts of Singapore.
17. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act, Chapter 53B of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
