

## Terms and Conditions for Dash at Lazada Black Friday Cyber Monday Promotion

1. These Terms and Conditions for the Dash at Lazada Black Friday Cyber Monday Promotion ("**Promotion**") are binding on all persons participating in the Promotion jointly organised by SingCash Pte Ltd ("**Singtel**") and Lazada Singapore Pte. Ltd. ("**Merchant** or "**Lazada**").
2. The Promotion shall be from 26 November 2021 to 29 November 2021 (inclusive of both dates) ("**Promotion Period**").
3. Under the Promotion, and subject to these Terms and Conditions, existing Dash Customers ("**Eligible Customers**") may access Lazada's Application during the Promotion Period to collect Dash voucher ("**Voucher**"). This Voucher will entitle the Eligible Customer to obtain a discount of five dollars (S\$5) ("**Discount**") provided that a minimum of S\$99 worth of goods and/or services are successfully purchased using Dash Visa Virtual Account ("**Dash Payment Transactions**") or eight dollars (S\$8) ("**Discount**") provided that a minimum of S\$150 worth of goods and/or services are successfully purchased using Dash Visa Virtual Account ("**Dash Payment Transactions**") during the Promotion Period. The Voucher can be collected from 0000hrs on 23 Nov'21 to 2359hrs on 29 Nov'21. Voucher collection is refreshed daily at 0900hrs, 1200hrs and 1800hrs. Voucher redemption is valid only from 0000hrs on 26 Nov'21 to 2359hrs on 29 Nov'21. By redeeming the Lazada Voucher(s) referred to in this Clause, the Eligible Customers consent to the terms & conditions by Merchant available [here](#).

This Promotion is valid to a maximum redemption of 1821 during this Promotion Period. In addition, each Eligible Customer shall only be entitled to a maximum of one (1) redemption per voucher during the Promotion Period.

  - (a) Your Dash Balance must be and remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period; and

5. Voucher is applicable sitewide on Lazada, excluding RedMart orders.
6. Not applicable for Gold, Digital Goods, Toddler Formula (0 - 12 months) and shipping charges.
7. Voucher is applicable for redemption on Lazada's mobile application only.
8. Save and except for the rewards points receivable from the Dash First Use Promotion, this Promotion may not be combined with any other on-going promotions by Singtel unless otherwise stated.

16. These Terms shall be subject to and construed in accordance with the laws of Singapore and you hereby submit to the non-exclusive jurisdiction of the courts of Singapore.
17. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act, Chapter 53B of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
