

Terms and Conditions for "Singtel Dash 2021 CNY S\$6 Cashback for First Remittance Transaction to Alipay app Promotion"

- 1. The Singtel Dash 2021 S\$6 Cashback for First Remittance Transaction to Alipay app (the "**Promotion**") is a promotion organised by SingCash Pte Ltd ("**SCPL**") and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of SCPL, which shall be final and binding in all respects.
- 2. The Promotion is available from 01 February 2021 and will end on 28 February 2021 (both dates inclusive) (the "**Promotion Period**").
- 3. Under the Promotion, and subject to these Terms and Conditions, eligible Dash Remittance Customers ("Eligible Participants") who utilizes the Dash Remittance services to perform a single remittance transaction to an Alipay app, where the amount received by the end recipient is no less than RMB2500 ("First Time Remittance Transaction to Alipay app") shall be entitled to receive a cashback of S\$6("Cashback") credited to its Dash Balance Account provided always that (a) the remittance transaction is successfully completed within the Promotion Period and (b) there is no prior remittance made by the Eligible Participant to any Alipay app.

Eligibility

- 4. Eligible Participants must:
 - a) hold a valid Dash Remittance Account and Dash Balance Account, and the said accounts must remain valid, and must not for any reason be terminated and/or suspended, during the Promotion Period, and
 - b) comply at all times (including, but not limited to, in making the top up and remittance transactions) with all applicable laws including the terms and conditions governing the use of Dash Remittance Service and Dash Balance, including, but not limited to, the Dash Terms and Conditions and Remittance Terms and Conditions (both of which may be accessed at https://www.dash.com.sg/terms-and-conditions/).

SCPL reserves the right to request for the Eligible Participant's proof of identity for the purposes of verifying that the Dash Remittance Account and Dash Balance Account from which the First Time Remittance Transaction to Alipay app has been made is registered to the Eligible Participant. In the absence of such verification as requested, SCPL shall be entitled at its discretion to disqualify the Eligible Participant from the Promotion, and the Eligible Participant shall have no claim whatsoever against SCPL or any company within the Singtel Group in such event.

- 5. The Cashback will be credited to Eligible Participant's Dash Balance Account within 14 working days after the successful completion of the First Time Remittance Transaction to Alipay app.
- 6. Notwithstanding anything herein contained, the Eligible Participant's Dash Balance Account can only hold, in aggregate, a maximum amount of S\$3,000 (or such other amount as SCPL may determine in its discretion from time to time) at any point in time. SCPL shall not be required to credit the Cashback or



any part thereof to the Eligible Participants' Dash Balance Account in excess of such limit. The Cashback, or any part thereof that is not credited for such reason shall be forfeited at the sole and absolute discretion of SCPL, and the Eligible Participant shall not be entitled to any compensation for the same.

- 7. Employees of the companies within the Singtel Group and its appointed advertising, media and auditing agencies, and any other parties, who are directly involved in the organizing, promoting or conducting of the Promotion (collectively "Organising Committee") shall not be eligible to participate in the Promotion.
- 8. For the avoidance of doubt, participation in the Promotion is open to individuals only. Corporate or other entities shall not be eligible to participate in the Promotion.
- 9. SCPL reserves the right to request for the Eligible Participant's proof of eligibility. In the absence of such proof and verification thereof, SCPL shall be entitled at its discretion to disqualify the Eligible Participant from the Promotion, and the Eligible Participant shall have no claim whatsoever against any company within the Singtel Group ("Singtel Group") in such event.
- 10. SCPL reserves the right to disqualify any one or more of the Eligible Participants, if
 - a) The Eligible Participant is determined, at SCPL's sole discretion, to be ineligible for any reason whatsoever,
 - b) at any time, SCPL, at its sole and absolute discretion, suspects any fraud in relation to, and/or misuse of, the Eligible Participant's Dash Balance Account and/or Dash Remittance Account; or
 - c) the phone number which is registered in respect of the Eligible Participant's Dash Balance Account and/or Dash Remittance Account is for any reason changed (whether by the Eligible Participant or any other person, with or without the consent or knowledge of the Eligible Participant).

General

- 11. By participating in the Promotion, the Eligible Participants consent to Singtel Group's (which includes SCPL) collection, holding, storage, use, processing, transfer, disclosure and/or reporting (whether directly or indirectly) to any relevant third party, of such Eligible Participants' personal data and/or information provided to SCPL, for the purposes of administering the Eligible Participants' registration, organizing and promoting the Promotion, or otherwise for purposes relating to the Promotion; and the Eligible Participants further consent and acknowledge that their personal data and/or information (i) will also be processed in line with Singtel's privacy statement available at https://www.dash.com.sg/terms-and-conditions/ and (ii) may be used in accordance with Singtel's policies, terms and conditions or notices made available by Singtel Group from time to time.
- 12. SCPL reserves the right, at its sole and absolute discretion, to vary, modify and amend any of these Terms and Conditions and/or to suspend, discontinue or terminate the Promotion at any time without

- 13. SCPL reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Promotion, including the Eligible Participants' eligibility and the applicable criteria. SCPL's determination of all matters relating to this Promotion shall be final and binding and no appeal or objection on any grounds will be entertained.
- 14. Unless otherwise stated, this Promotion is valid with other offers, discounts, rebates, vouchers, privileges or promotions.
- 15. In the event of any inconsistency between these Terms and Conditions and any brochure, marketing or promotion material relating to the Promotion, these Terms and Conditions shall prevail.
- 16. By participating in the Promotion, each Eligible Participant agrees to fully and effectively indemnify, defend and hold harmless Singtel Group including SCPL and the Organising Committee (collectively the "Indemnified Parties") from and against any and all demands, claims, causes of action, losses, damages, costs and expenses whatsoever that the Indemnified Parties may have, or which may arise, whether in whole or in part, and whether directly or indirectly, due to or arising out of carrying out the Promotion. These obligations will continue to survive the completion of the Promotion.
- 17. To the extent permitted by law, the Indemnified Parties shall not be liable in any way to any Eligible Participant or any other person for any losses or damages of any kind, including but not limited to direct, indirect, incidental, consequential, special or punitive damages arising out of or in connection with the Promotion, including without limitation, from any late or non-notification, any errors, any technical, hardware or software breakdown, malfunction or defects, failed delayed or incorrect transactions, lost or unavailable network connections or any notice that is lost or misdirected.
- 18. These Terms and Conditions shall be subject to and construed in accordance with the laws of Singapore and the Eligible Participants hereby submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
- 19. A person who is not a party to these Terms and Conditions has no rights under the Contracts (Rights of Third Parties) Act of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
