



## Terms and Conditions for Singtel Dash Remit Hall C \$10 cashback from 1 Feb 2023 to 31 Mar 2023

1. The Singtel Dash Remit Hall C \$10 cashback (the "Promotion") is a promotion organised by SingCash Pte Ltd ("Singtel") and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of Singtel, which shall be final and binding in all respects.
2. The Promotion is available from 1 February 2023 to 31 March 2023, (both dates inclusive) (the "**Promotion Period**"). This Promotion Period may be changed by Singtel where it deems appropriate, in its sole and absolute discretion.
3. Under the Promotion, and subject to these Terms and Conditions, an eligible customer ("**Eligible Participant**") who:
  - (a) signs up for a Dash account ("New Dash Account"), during the Promotion Period, with the promo code (which can be obtained from the redemption card ("Redemption Card") collected from MOM Services Centre at 1500 Bendemeer Road, Singapore 339946), shall receive a \$10 Dash credits ("Cashback") credited to its New Dash Account immediately upon its activation, provided always that this Cashback may only be retained by the Eligible Participant if it completes its first remittance, via the New Dash Account, within thirty (30) days of its activation or by 14 April 2023, whichever is earlier; OR
  - (b) in respect of a Dash Account that was activated prior to the start of the Promotion, completes the Know Your Client process ("KYC") successfully, during the Promotion Period, in the presence of an authorised Singtel Dash staff stationed at the Dash Remit Flagship Store, Lucky Plaza, #01-11 ("Singtel Flagship Shop"), shall receive the Cashback credited to its Dash Account immediately upon completion of the KYC (without any adverse results), provided always that this Cashback may only be retained by the Eligible Participant if it completes its first remittance, via its Dash Account, within the Promotion Period.

Each Eligible Participant is limited to one (1) Cashback only.

To be eligible for the Cashback, the Eligible Participant must, upon Singtel's request, present the Redemption Card to the authorised Singtel Dash staff stationed at a Singtel Flagship Shop.

### **Eligibility**

4. To be eligible for the Promotion, the participant must:
  - a) hold a valid Dash Account, which said account must at all times be and remain valid and must not for any reason be terminated and/or suspended;
  - b) comply at all times with the terms and conditions governing the use of the Dash account, including, but not limited to, the Dash Terms and Conditions ( which may be accessed at <https://www.dash.com.sg/terms-and-conditions/>).
  - c) Singtel reserves the right to request for the Eligible Participant's proof of identity for the purposes of verifying that the Dash Account is registered to the Eligible Participant. In the



absence of such verification as requested, Singtel shall be entitled in its discretion to disqualify the Eligible Participant from the Promotion, and the Eligible Participant shall have no claim whatsoever against Singtel in such event.

5. Singtel reserves the right to disqualify any one or more of the Eligible Participants from this Promotion, and/or remove, or refrain from awarding, the Cashback if:
  - a) The Eligible Participant is determined, in Singtel's sole discretion, to be ineligible for any reason whatsoever,
  - b) at any time, Singtel, at its sole and absolute discretion, suspects any fraud, collusion, and/or unlawful activity in relation to, and/or misuse of, the Eligible Participant's Singtel Dash Account;
  - c) the phone number which is registered in respect of the Eligible Participant's Singtel Dash Account is for any reason changed (whether by the Eligible Participant or any other person, with or without the consent or knowledge of the Eligible Participant);
  - d) at any time, Singtel reasonably believes that the Eligible Participant is involved in manipulating, rigging, abusing, cheating the underlying system (or a third party system) or is otherwise engaged in any activity calculated to game such system or gain an unfair advantage;
  - e) KYC on the Eligible Participant yields an adverse result;
  - f) any of these Terms and Conditions are not complied with by the Eligible Participant including (without limitation) the obligation to complete the first remittance as outlined under paragraph 3 above;
  - g) at any time, Singtel, at its sole and absolute discretion, suspects any breach of any applicable law by or involving the Eligible Participant; OR
  - h) there is a reversal, cancellation, termination or revocation of the successful remittance transaction (or a refund is made to the Eligible Participant for any reason whatsoever).

### **General**

6. By participating in the Promotion, the Eligible Participant consents to Singtel's collection, holding, storage, use, processing, transfer, disclosure and/or reporting (whether directly or indirectly) to any relevant third party, of its personal data and/or information provided to Singtel, including but not limited to, for the purposes of administering the Eligible Participant's registration, organizing and promoting the Promotion, or otherwise for purposes relating to the Promotion; and the Eligible Participant further consents and acknowledges that its personal data and/or information (i) will also be processed in line with Singtel's privacy statement available at <https://dash.com.sg/files/terms/privacy-policy1.pdf>; and (ii) may be used in accordance with Singtel's policies, terms and conditions or notices made available by Singtel from time to time.
7. Singtel reserves the right, at its sole and absolute discretion, to vary, modify and amend any of these Terms and Conditions and/or to suspend, discontinue or terminate the Promotion at any time without prior notification, or liability to any party.
8. Singtel reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Promotion, including the participant's eligibility, the applicable criteria and whether all relevant terms and conditions of the Promotion have been complied with to the satisfaction of Singtel. Singtel's determination of all matters relating to this Promotion shall be final and binding and no appeal or objection on any grounds will be entertained.



9. In the event of any inconsistency between these Terms and Conditions and any brochure, marketing or promotion material relating to the Promotion, these Terms and Conditions shall prevail.
10. By participating in the Promotion, each Eligible Participant agrees to fully and effectively indemnify, defend and hold harmless Singtel from and against any and all rights, demands, claims, causes of action, losses, damages, costs and expenses whatsoever that Singtel may have, or which may arise, whether in whole or in part, and whether directly or indirectly, due to or arising out of or in connection with the Promotion. These obligations will continue to survive the expiry or termination of the Promotion.
11. To the extent permitted by law, Singtel shall not be liable in any way to any participant or any other person for any losses or damages of any kind, including but not limited to direct, indirect, incidental, consequential, special or punitive damages arising out of or in connection with the Promotion, including without limitation, from any late or non-notification, any error in computing chances, any technical, hardware or software breakdown, malfunction or defects, failed delayed or incorrect transactions, lost or unavailable network connections or any notice that is lost or misdirected, any delay to the crediting of the Cashback or any removal of the Cashback from a participant's Dash account.
12. These Terms and Conditions shall be subject to and construed in accordance with the laws of Singapore and the Eligible Participants hereby submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
13. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
