

## Terms and Conditions for Dash Remittance and Prepaid Top-up Gold Bar Giveaway Promotion

1. These Terms and Condition for the Dash Remittance and Prepaid Top-up Gold Bar Giveaway Promotion (“**Promotion**”) is a giveaway promotion organised by SingCash Pte Ltd (“**SingCash**”) and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of SingCash, which shall be final and binding in all respects.
2. The Promotion shall run for the period starting from 18 November 2024 and ending on 31 December 2024 (inclusive of both dates) (“**Promotion Period**”)

### **Eligibility**

3. To be eligible for the Promotion, the participant must:
  - (I) Hold a valid SingCash Remittance Account and Dash Balance Account, which said accounts must be and remain valid and must not for any reason be terminated and/or suspended, during the Promotion Period, and
  - (II) comply at all times (including, but not limited to, in making the Eligible Transaction) with the terms and conditions governing the use of SingCash Remittance Service and Dash Balance, including, but not limited to, the Dash Terms and Conditions and Remittance Terms and Conditions (both of which may be accessed at <https://www.dash.com.sg/terms-and-conditions/>).
4. Employees of the Singtel Group of Companies and its appointed advertising, media and auditing agencies and any other parties who are directly involved in the organizing, promoting or conducting of the Giveaway (as defined below) shall not be eligible to participate in the Promotion.
5. For the avoidance of doubt, participation in the Promotion is open to individuals only. Corporate or other entities shall not be eligible to participate in the Promotion.
6. SingCash reserves the right to request for the participant’s proof of identity for the purposes of verifying that the Dash Account from which the Eligible Transactions have been made is registered to the participant. In the absence of such verification as requested, SingCash shall be entitled in its discretion to disqualify the participant from the Promotion, and the participant shall have no claim whatsoever against SingCash in such event.

10. The prizes will be given to eligible participants on a first-come-first-served basis, during the Giveaway Dates that correspond to the Relevant Period in which they completed both qualifying transactions:
  - (I) During each set of Giveaway Dates, redemption of the Prizes will be limited to the first 50 eligible participants who arrive at Singtel mRemit Lucky Plaza.

SingCash reserves the right to request for the Winners’ proof of eligibility, identity and/or otherwise for the purposes of verifying the Winners’ claim to the Prize.

Any Prize which is not claimed or received in accordance with the provisions of these Terms and Conditions and within the last set of Giveaway Dates (3 January 2025 till 5 January 2025) will be forfeited at the sole and absolute discretion of SingCash, and the Winner shall not be entitled to any compensation for the same.

SingCash makes no warranty, assurance, guarantee or representation on the quality, sufficiency, durability, reliability, value, suitability, viability, authenticity, legality, merchantability or fitness for purpose of any of the Prizes and/or third party goods/services and assumes no liability or responsibility for the acts or omissions of these third parties or any non-performance or defects in such Prizes, goods, products or services.
18. SingCash shall be entitled, at SingCash’s sole and absolute discretion and without notice to you, to claw-back from you any Giveaway Prize which has, in SingCash’s sole opinion, been wrongfully awarded to you for any reason whatsoever, including by reason of any failed remittance.

27. These Terms and Conditions shall be subject to and construed in accordance with the laws of Singapore and the eligible participant hereby submits to the exclusive jurisdiction of the courts of Singapore.
28. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act, Chapter 53B of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
