

## Terms and Conditions for "Singtel Dash - Huat Dash Draw 2024"

The Singtel Dash – Huat Dash Draw 2024 (the "**Promotion**") is a closed-door lucky draw promotion organised by SingCash Pte Ltd ("**SingCash**") and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of SingCash, which shall be final and binding in all respects.

1. The Promotion will commence from 17 January 2024 and end on 29 February 2024 (both dates inclusive) (the "Promotion Period"). With respect to this Promotion, and subject to these Terms and Conditions, for every successful remittance, made by a participant via the Dash app ("Remittance"), the participant shall be entitled to participate in a lucky draw held on a weekly basis ("Weekly Bonus Draw"), details of which are as follows:

And in addition to the above, for every two (2) Remittance completed within the Promotion Period, the participant shall be further entitled to one (1) lucky draw chance at the Grand Draw held on 12 March 2024,

## **Eligibility**

- 2. To be eligible for the Promotion, the participant must:
  - a) hold a valid Singtel Dash and Dash Remit accounts, which said accounts must at all times be and remain valid and must not for any reason be terminated and/or suspended; and



- b) comply at all times with the terms and conditions governing the use of Dash account and Dash Remit account, including, but not limited to, the Dash Terms and Conditions and Dash Remit Terms and Conditions (both of which may be accessed at <a href="https://www.dash.com.sg/terms-and-conditions/">https://www.dash.com.sg/terms-and-conditions/</a>.
- 3. For the avoidance of doubt, participation in the Promotion is open to individuals only. Corporate or other entities shall not be eligible to participate in the Promotion.
- 4. SingCash reserves the right to request for the participant's proof of identity for the purposes of verification. In the absence of such verification as requested, SingCash shall be entitled in its discretion to disqualify the participant from the Promotion, and the participant shall have no claim whatsoever against SingCash in such event.

- 6. Whether a Remittance is successful and eligible for this Promotion shall be determined at the sole discretion of SingCash.

- 8. The Winners will be selected at random through a computerised system in the presence of an authorised personnel of SingCash. SingCash reserves the right to disqualify any Winner, and to select another person to replace any such Winner. - 9. SingCash further reserves the right, at its absolute discretion, to change or substitute the Prize and/or to increase or reduce the number of Winners for the Lucky Draw.
- 10. The Winners for the Lucky Draw will be notified via SMS or Whatsapp or In-app Push Notification to their Singtel Dash registered telephone number within five (5) working days after the completion of the Lucky Draw, and the same SMS or Whatsapp or In-app Push Notification shall notify the Winners of the date on which the relevant Prizes shall be collected, delivered and/or credited into the respective Winners' Dash Account, as the case may be. The Winners shall comply with SingCash's instructions for all matters concerning the Lucky Draw. SingCash reserves the right to request for the Winners' proof of eligibility, identity and/or otherwise for the purposes of verifying the Winners.

SingCash reserves the right to disqualify any Winner from the Lucky Draw if (a) the Winner is determined, in SingCash's sole discretion, to be ineligible for any reason whatsoever, (b) at any time, SingCash, at its sole and absolute discretion, suspects any fraud, collusion or unlawful activity in relation to, and/or misuse of, the Winner's Dash Account or otherwise in connection with this Promotion; or (c) the phone number which is registered in respect of the Winner's Dash account is for any reason changed (whether by the Winner or any other person, with or without the consent or knowledge of the Winner); (d) at any time, SingCash reasonably believes that the Winner is involved in manipulating, rigging, abusing, cheating the underlying system (or a third party system) or is otherwise engaged in any activity calculated to game such system or gain an unfair advantage or (e) any of these Terms and Conditions are not complied with by the Winner or (f) if any applicable law is not complied with by the Winner; or (g) there is a reversal, cancellation, termination or revocation of the successful Remittance, or a refund is made to the participant, for any reason whatsoever.
