

Terms and Conditions for "Singtel Dash – Mega Dash Giveaway Oct - Nov 2022"

The Singtel Dash – Mega Dash Giveaway Oct - Nov 2022 (the "**Promotion**") is a closed-door lucky draw promotion organised by SingCash Pte Ltd ("**SingCash**") and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of SingCash, which shall be final and binding in all respects.

- The Promotion is available from 1 October 2022 and will end on 28 November 2022 (both dates inclusive) (the "Promotion Period"), during which a participant shall be entitled to one (1) Lucky Draw chance for undertaking any of the following:
 - a) Each successful redemption of a Lucky Draw voucher from the Dash Rewards catalogue located with the Dash app;
 - b) Each successful remittance made by the participant using the Singtel Dash App;
 - c) A successful sign up for a new Dash PET or UOBAM account via the Singtel Dash App;
 - d) Each successful top up by the participant of its own UOBAM account via the Singtel Dash App provided always that each participant shall only be entitled to a maximum of eight (8) Lucky Draw chances arising from multiple top ups, within the Promotion Period, of its own UOBAM account;
 - e) Each successful top up by the participant of its own Dash PET account via the Singtel Dash App provided always that each participant shall only be entitled to a maximum of eight (8) Lucky Draw chances arising from multiple top ups, within the Promotion Period, of its own Dash PET account; and
 - f) Each successful top up by the participant of its own Singtel Prepaid or Overseas Prepaid account through the Singtel Dash App provided always that each participant shall only be entitled to a maximum of eight (8) Lucky Draw chances arising from multiple top ups, within the Promotion Period, of either or both of its Singtel Prepaid or Overseas Prepaid accounts.

There will be one (1) round of giveaway, where winners will be drawn after the end of the Promotion Period.

Eligibility

- 2. To be eligible for the Promotion, the participant must:
 - a) hold a valid Singtel Dash and Dash Rewards accounts, which said accounts must at all times be and remain valid and must not for any reason be terminated and/or suspended; and
 - b) comply at all times with the terms and conditions governing the use of Dash account, Dash PET account, UOBAM account, Singtel Prepaid and Overseas Prepaid account, including, but not limited to, the Dash Terms and Conditions and Dash Rewards Terms and Conditions (both of which may be accessed at https://www.dash.com.sg/terms-and-conditions/).
- 3. Employees of the Singtel Group of Companies and its appointed advertising, media and auditing agencies and any other parties who are directly involved in the organizing, promoting or conducting of the Lucky Draw shall not be eligible to participate in the Promotion.

5. SingCash reserves the right to request for the participant's proof of identity for the purposes of verification. In the absence of such verification as requested, SingCash shall be entitled in its discretion to disqualify the participant from the Promotion, and the participant shall have no claim whatsoever against SingCash in such event.
